- TIN of Partnership
- Resolution (authorizing action sought and by whom)
- Certificate of Partnership
- Verification of status or good standing from Secretary of State

Not-For-Profit Organization

- TIN of Organization
- If incorporated, follow corporation guidelines
- If tax-exempt, IRS documentation or tax return
- If not tax-exempt, authorization letter

Corporation

- TIN of Corporation
- Articles of Incorporation
- Bylaws
- Verification of status or good standing from Secretary of State
- Resolution (authorizing action sought and by whom)

Fictitious Name Resolution may also be requested.
