
Where is My Tax Refund?

Learn how to check the status of your refunds

Curious about the status of your federal refund? Visit IRS.gov and click on the "Where's My Refund?" link, or visit the IRS2Go mobile app to view updates.

If you have the Earned Income Tax Credit, or the Child Tax Credit on your return, there is a chance your refund might be delayed. The IRS issues most refunds within 21 days of being e-filed, but it can take more than six weeks if you mailed your return.

You can check your lowa refund status by visiting Tax.iowa.gov and clicking on the "Where's My Refund?" link. The team of tax professionals at DeWitt Bank Tax & Accounting are available to answer any questions you might have regarding taxes. Contact them at (563) 659-5175.

Simple Ways to Protect Your Personal Data

Shred Printed Documents

Make sure you shred any documents that contain sensitive information, such as Social Security, credit card or bank account numbers. That will prevent criminals from pulling them out of your trash and using them to establish online identities.

Lock Your Phone

Most people store vast amounts of personal information on their cell phone, which is why locking your phone with a pass code is crucial to ensuring thieves don't gain easy access to your bank accounts, email and other personal data.

Be Cautious Shopping Online

Online shopping has created an extra level of convenience, but with that comes another avenue for cybercriminals to compromise your data. Only shop from known and trusted sources, and before entering credit card info, make sure the word, "secure," or a closed padlock icon appear next to the URL in the web address bar.

Set Strong Passwords

Cybercriminals are becoming more sophisticated in how they are able to obtain victims' login information. Setting strong passwords that use a variety of letters, numbers and special characters helps to prevent criminals from accessing your personal information.


Before Clicking on a Link - Check the URL

Cybercriminals often gain access to personal information through phishing scams. Phishing is used to obtain sensitive information by disguising a fraudulent electronic communication as a trustworthy entity. When you click on a link and enter your information, it is automatically transferred to the criminal. Before clicking on any links, examine the email carefully for signs that it may be fraudulent. Signs include misspelling, poor grammar or a return email address that doesn't match the organization name. If you are unsure whether the communication is fraudulent or not, contact the sender organization directly without clicking on any links.


